CIPHI Ontario Branch Award of Merit for Outstanding Achievement in Public Health in Ontario

Application Criteria

This award is given to a CIPHI Ontario Branch public health professional for his or her outstanding achievements in the field of public health. Achievement in the following areas will be considered:

- Environmental Health Protection and Promotion
- Infection, Prevention and Control
- Quality Client Service
- Innovation
- Career Achievement
- Valuing People, Leadership
- Professional Achievement and/or lifetime achievement.

Eligible recipients are reviewed and selected by the Membership Committee who will then forward applicants to Ontario Branch Executive Council for final approval of selected candidates.

Criteria:

- a) Applicant must be a member in good standing for the two consecutive years prior to their application in order to receive the award of merit.
- b) Applicant must have made a significant contribution to the environmental public health profession. This contribution must be demonstrated through an achievement or milestone event (e.g. Work in a Master's program, significant contribution to a public health unit impacting the greater community) and demonstrated through the applicant's professional profile within the field of public health.

Application Process:

- a) The nominator must complete the attached application and submit it to the Membership Support and Engagement Councillor (membership@ciphi.on.ca).
- **b)** The significant contribution must have occurred within the calendar year prior to award application.
- **c)** The nominator must provide supplemental information to evidence significant contribution to the profession or environmental health through an achievement or milestone event and through the applicant's professional profile in the field of public health.
- **d)** Letters of support from the broader public health community supporting the impact of the achievement are encouraged.
- **e)** Describe the achievement and explain, in plain language, why the achievement was above and beyond the nominee's regular work. Note that extra materials such as publications, brochures and videos *should not* be submitted.
- **f)** The membership committee will review the applications. Nominee(s) will be contacted within 30 days of the application deadline.

Remittance of Award:

a) The award letter, trophy and plaque for the CIPHI Ontario Branch Award of Merit for Outstanding Achievement in Public Health in Ontario will be awarded at the AGM and presented at the Awards luncheon during the provincial annual educational conference.
